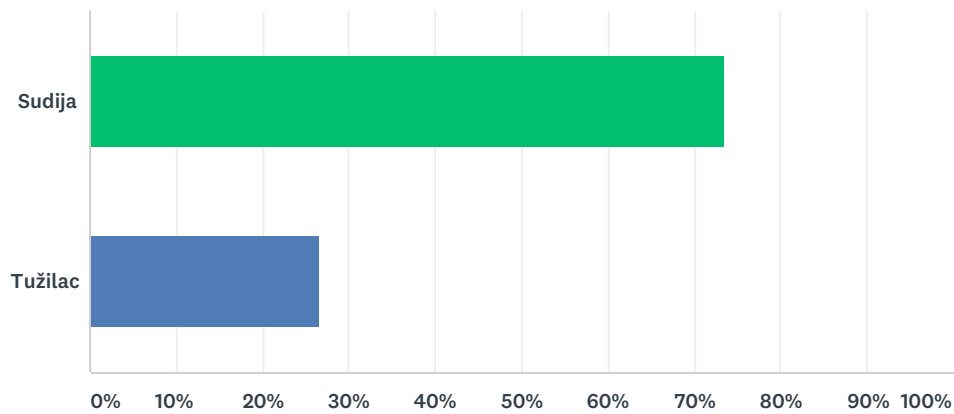

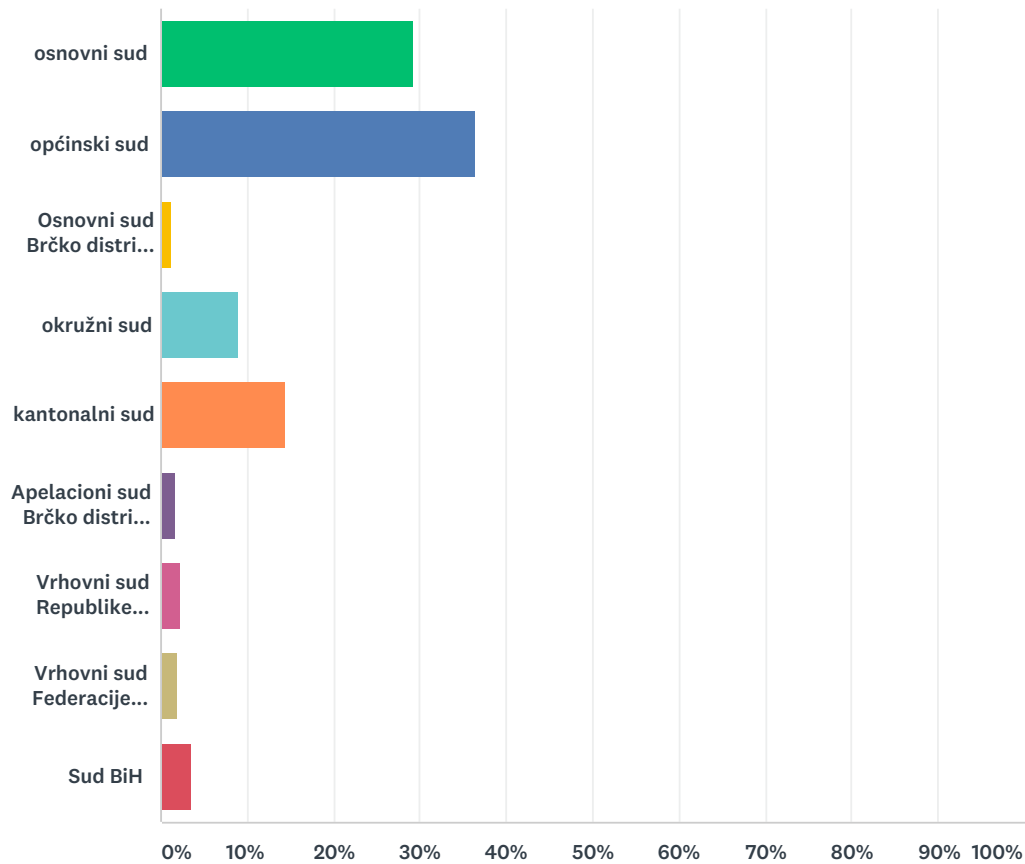

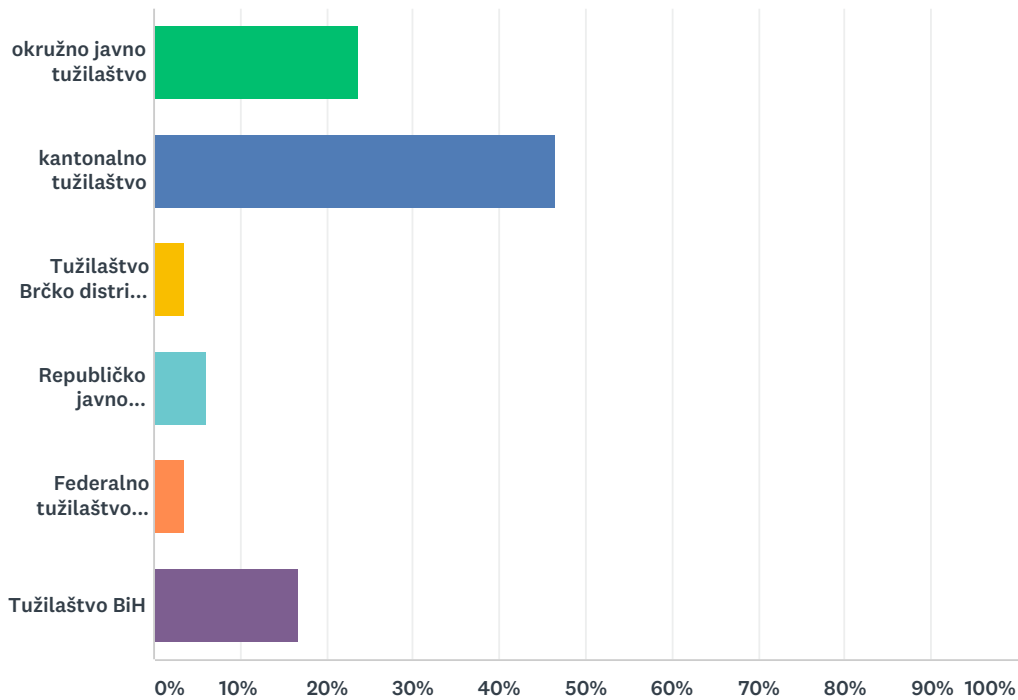
Q2 Na kojem nivou suda obavljate sudijsku funkciju?

Q3 Na kojem nivou tužilaštava obavljate tužilačku dužnost?

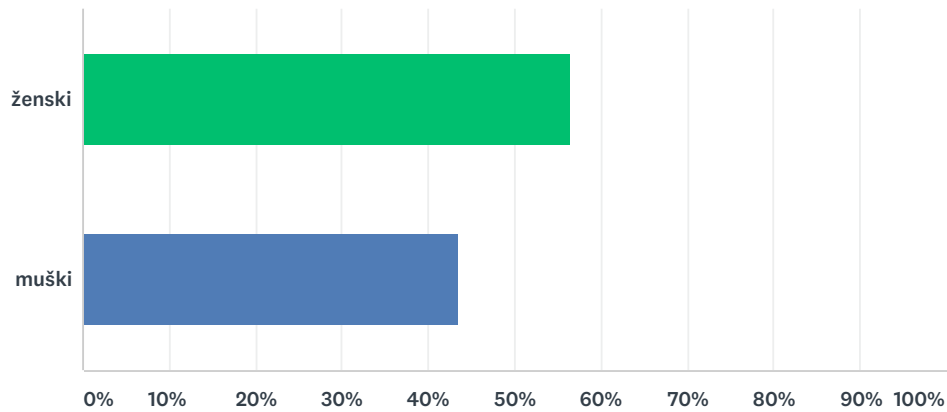

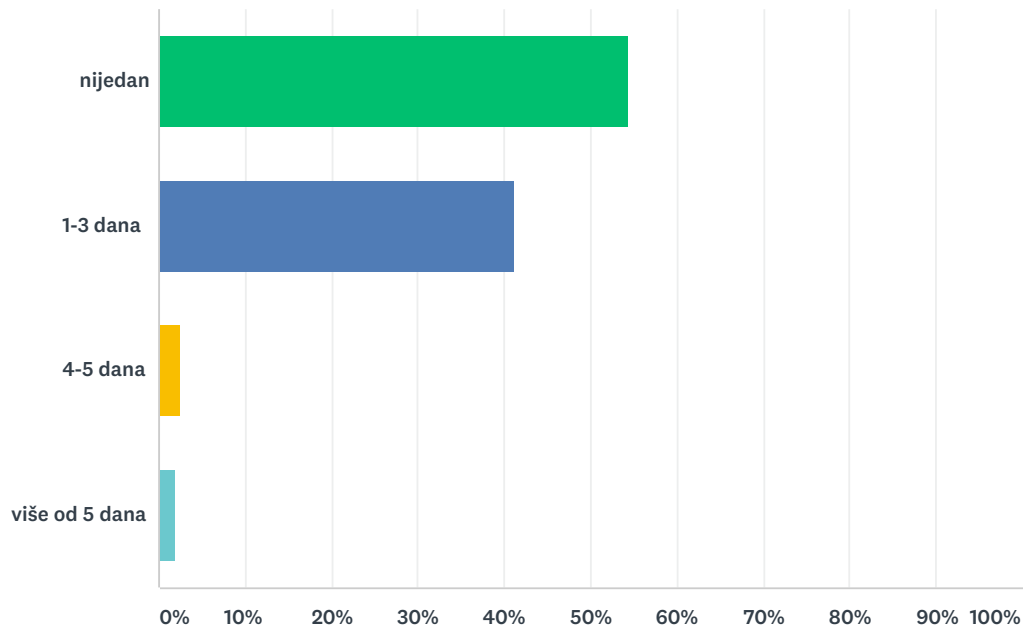

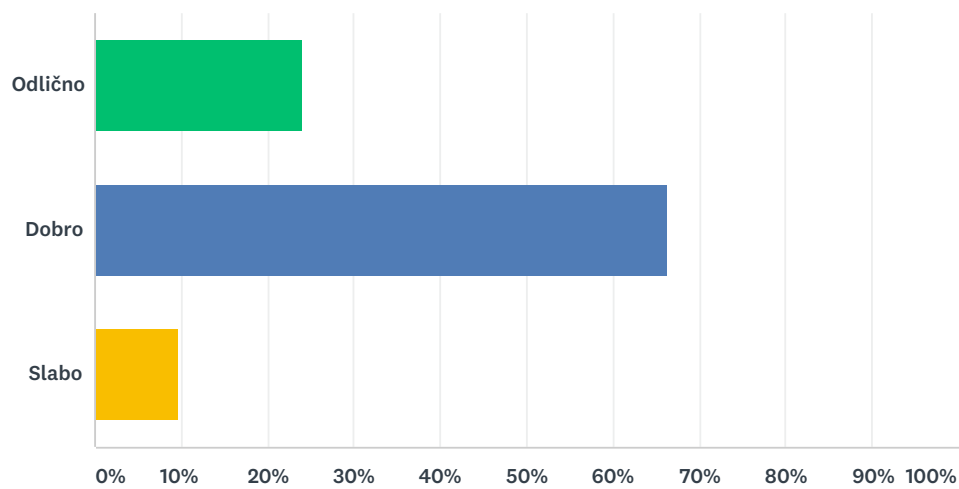

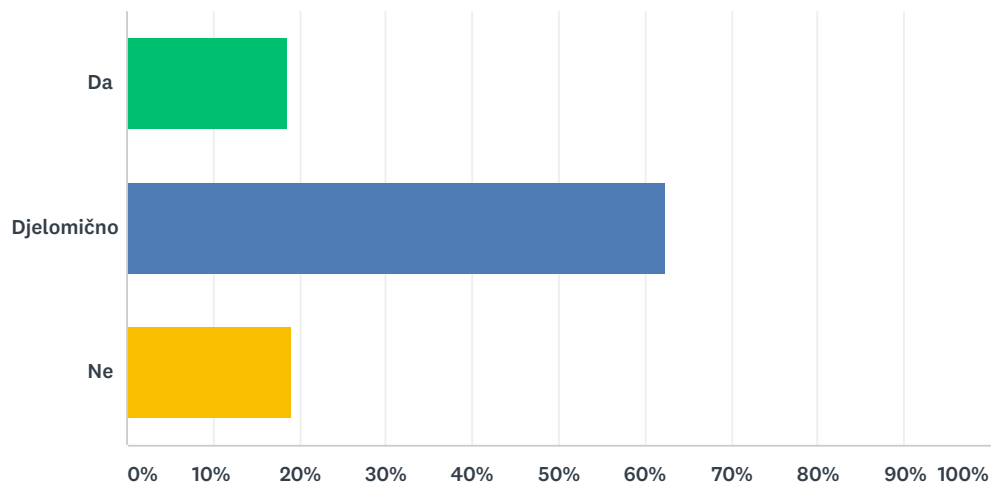

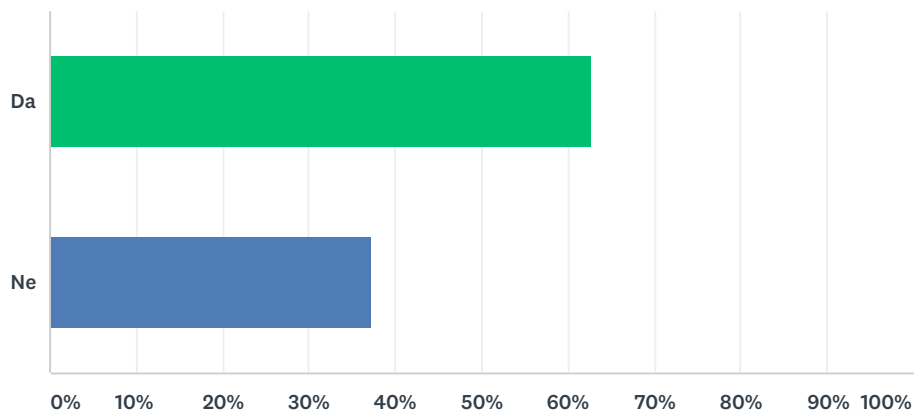

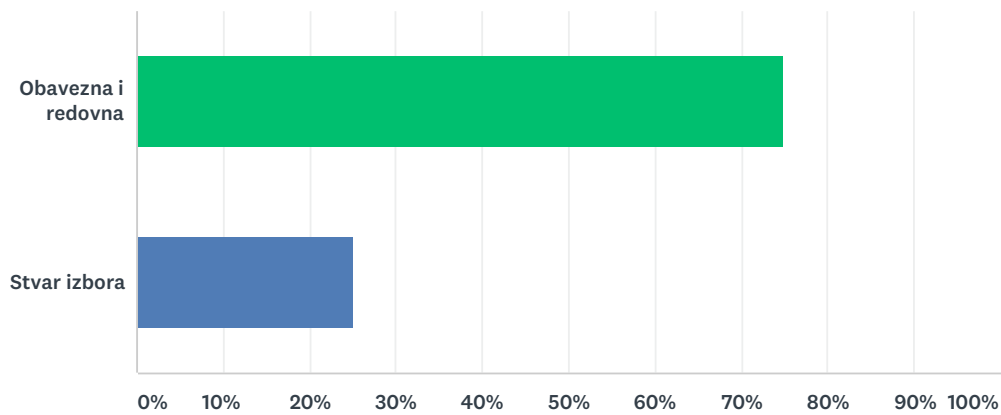

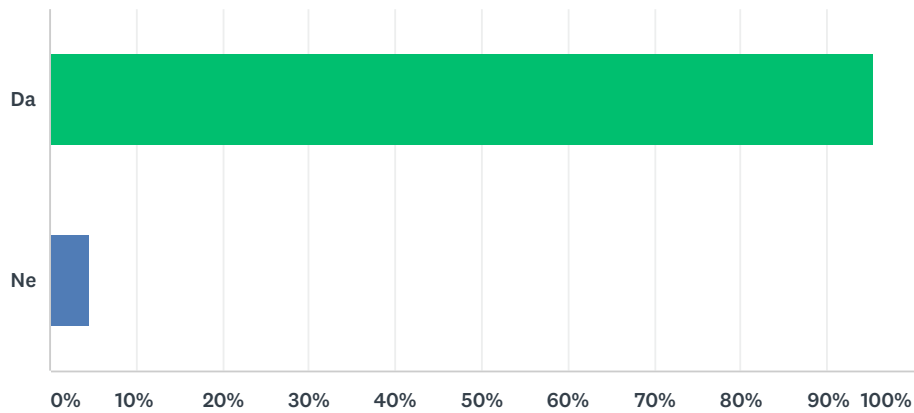

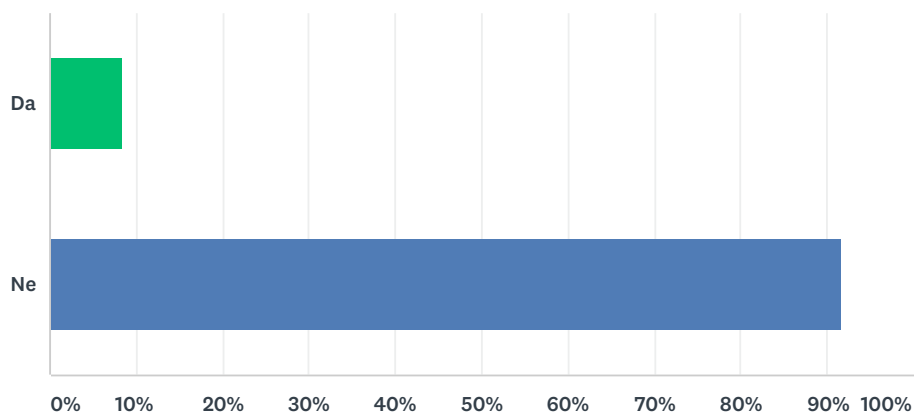

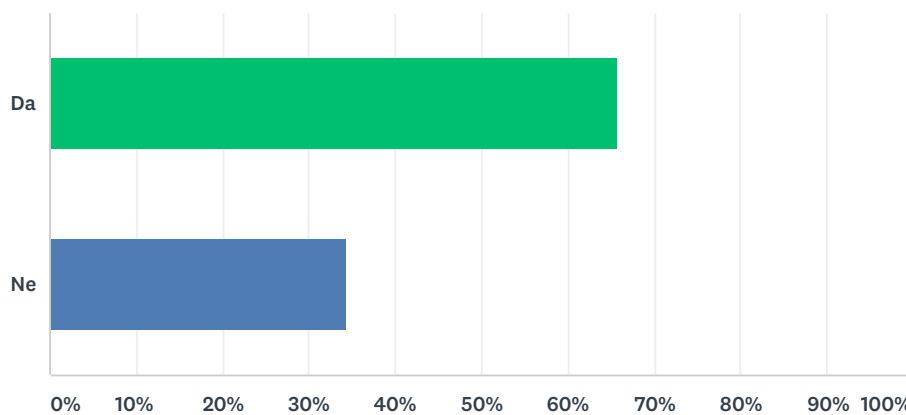

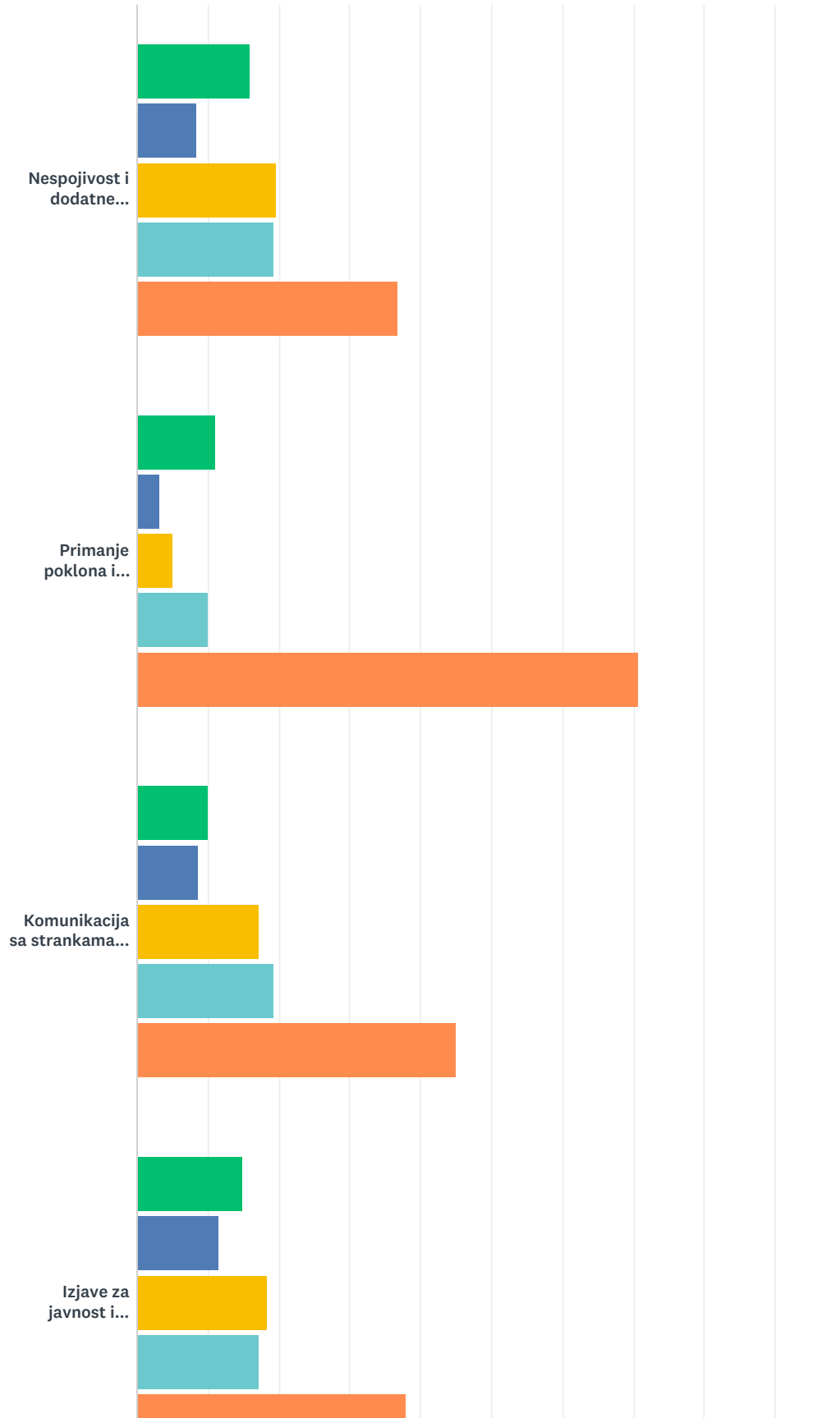

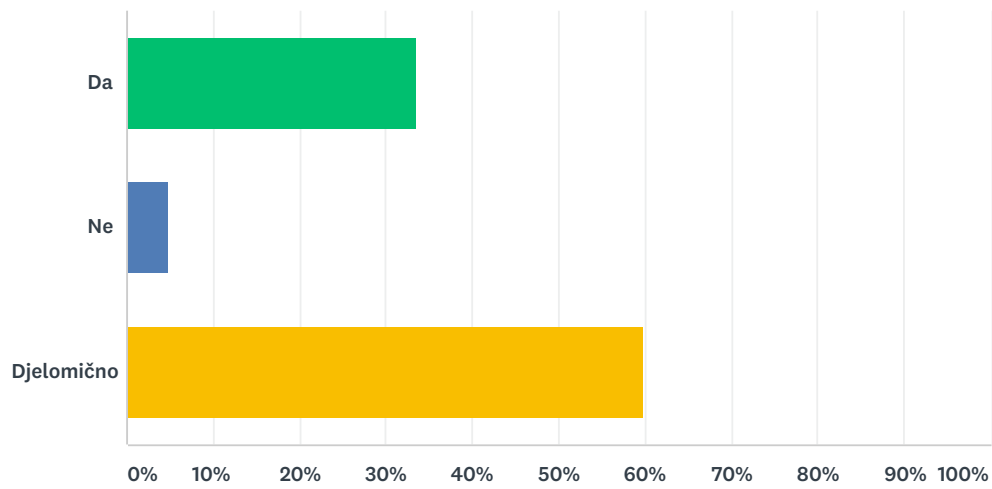

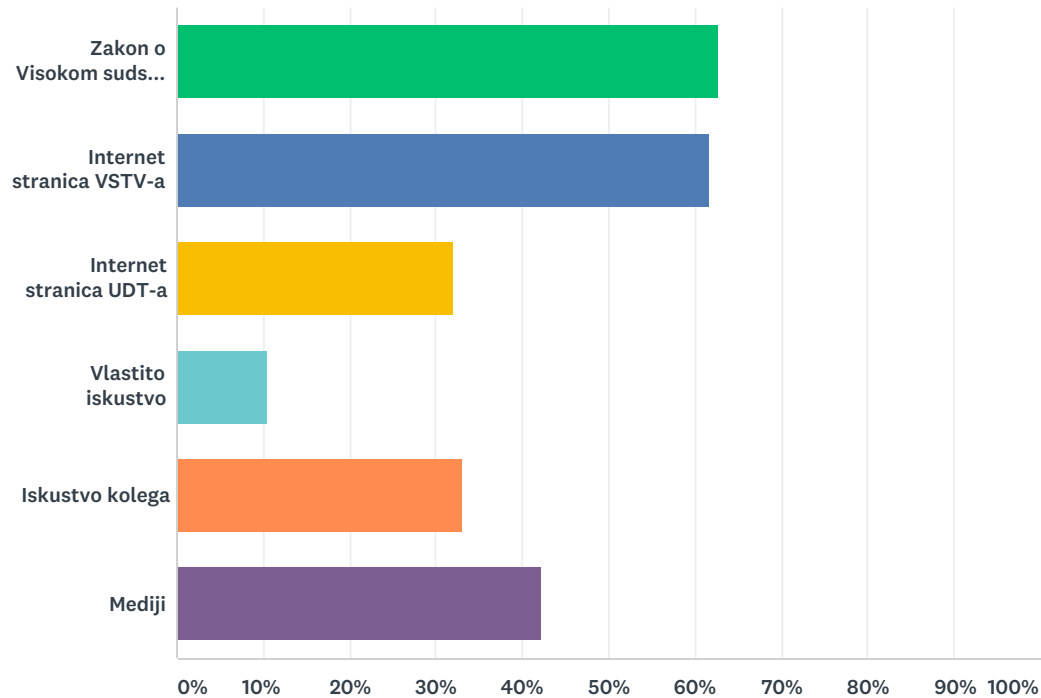

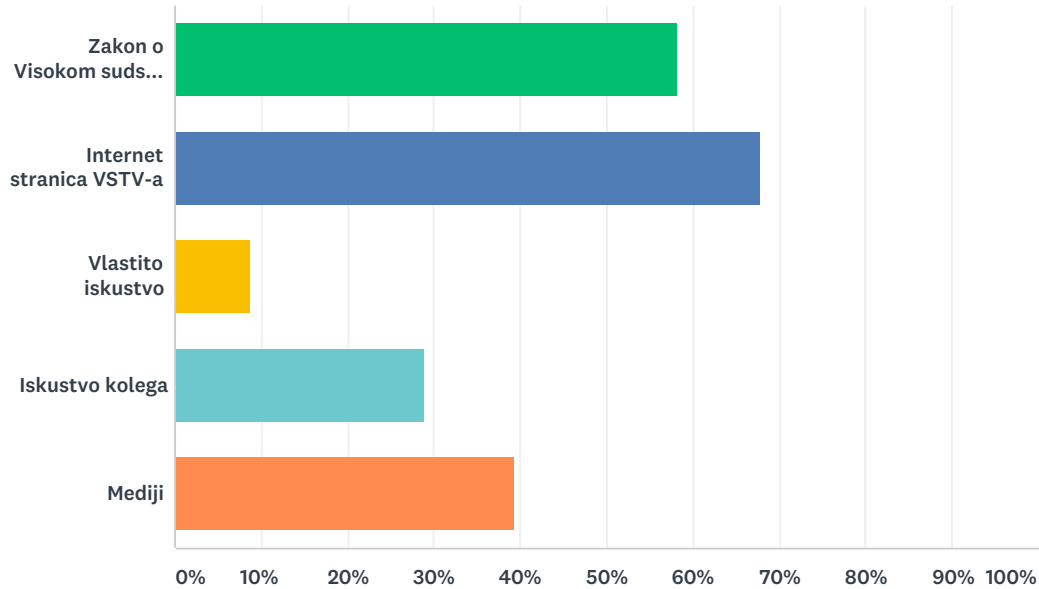

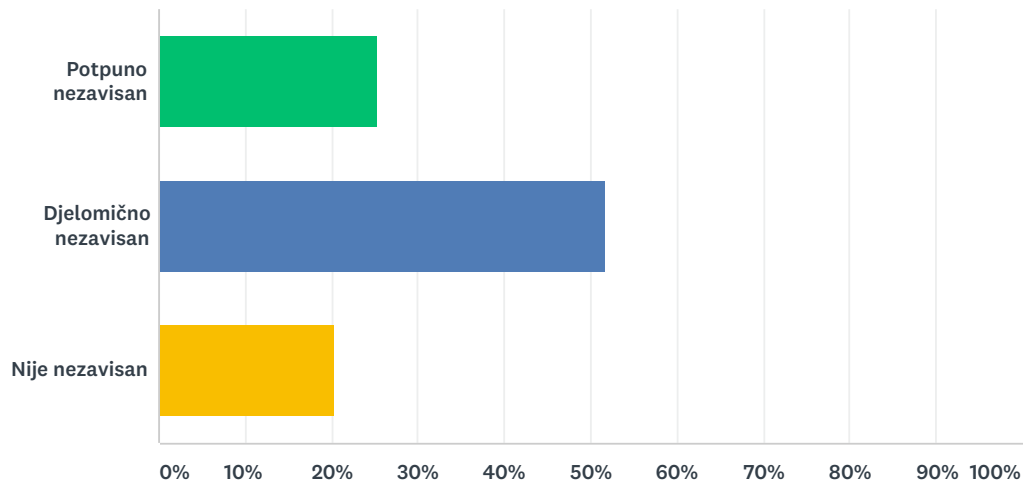

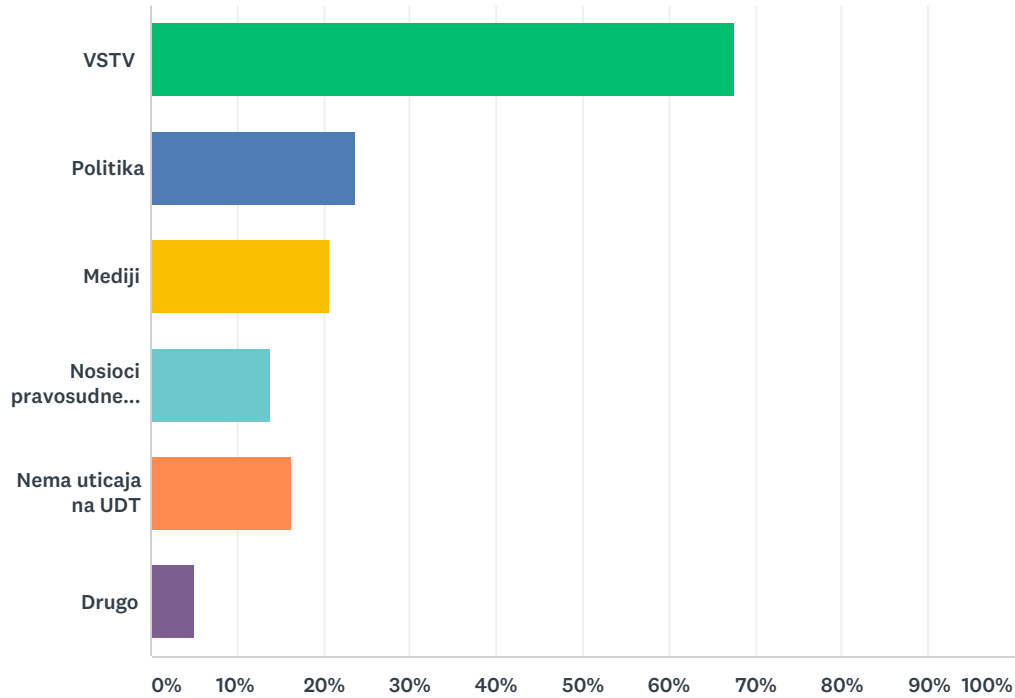
Q23 Kako ocjenjujete nivo institucionalne nezavisnosti Ureda disciplinskog tužioca (UDT)?

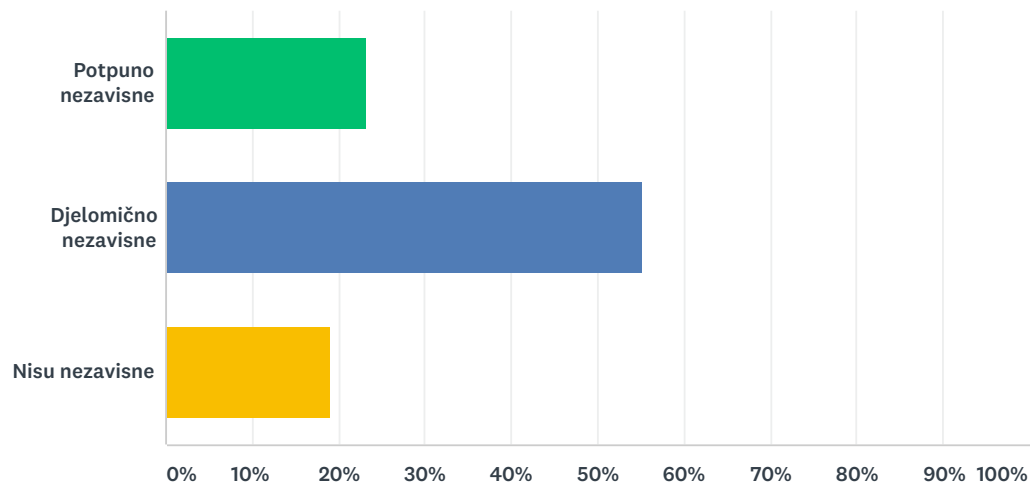

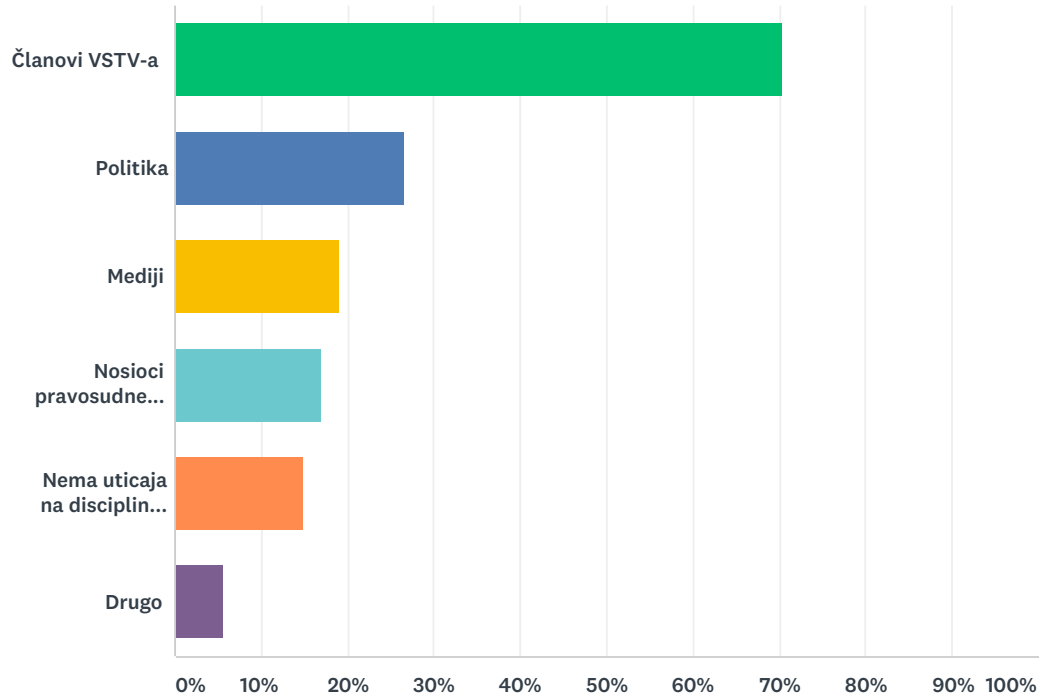

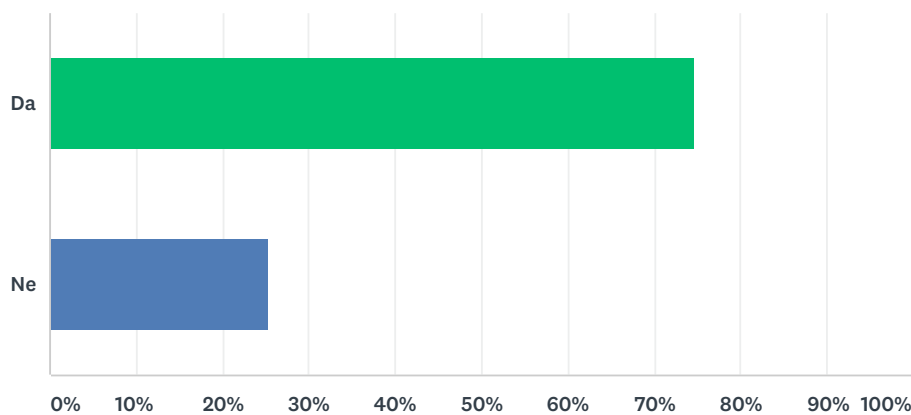

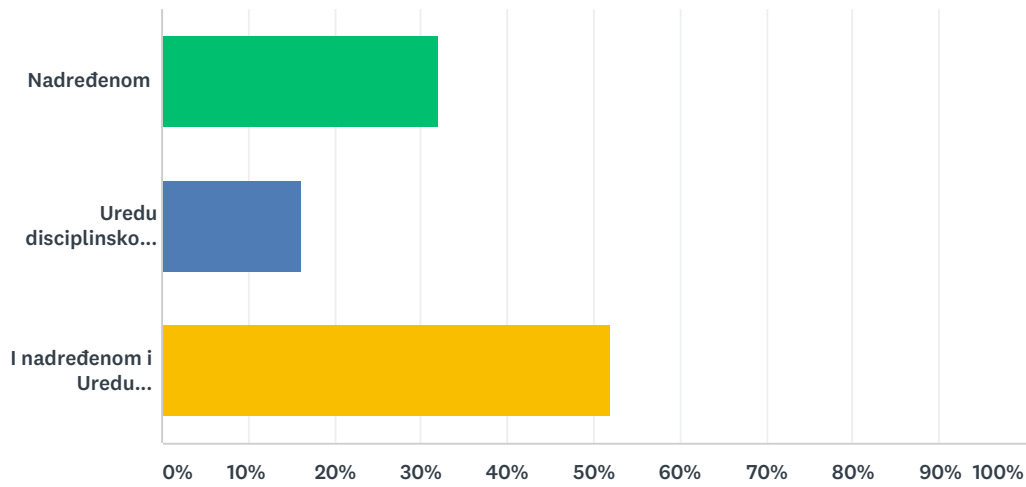

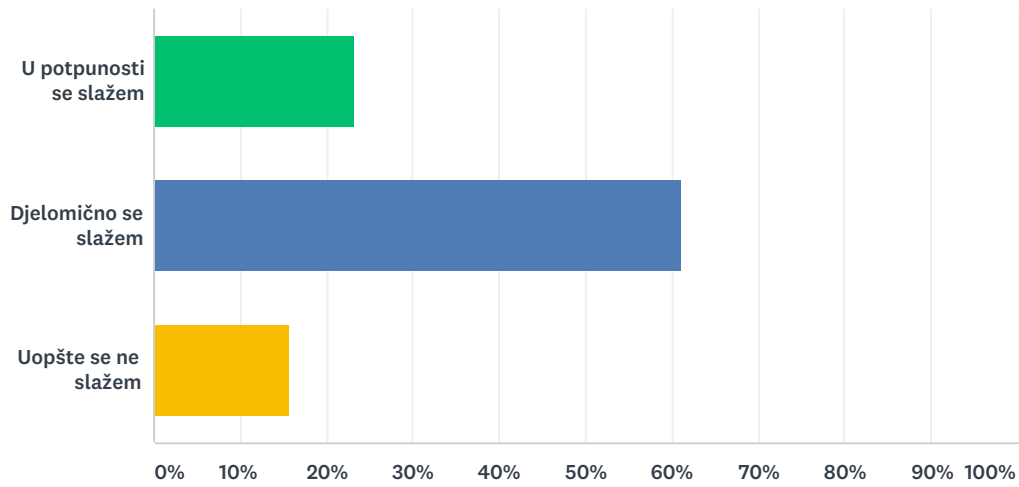

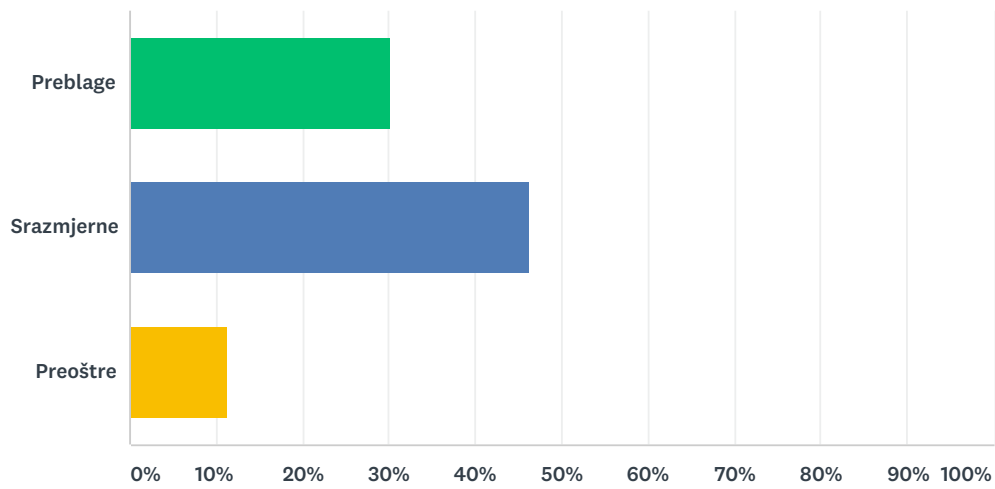

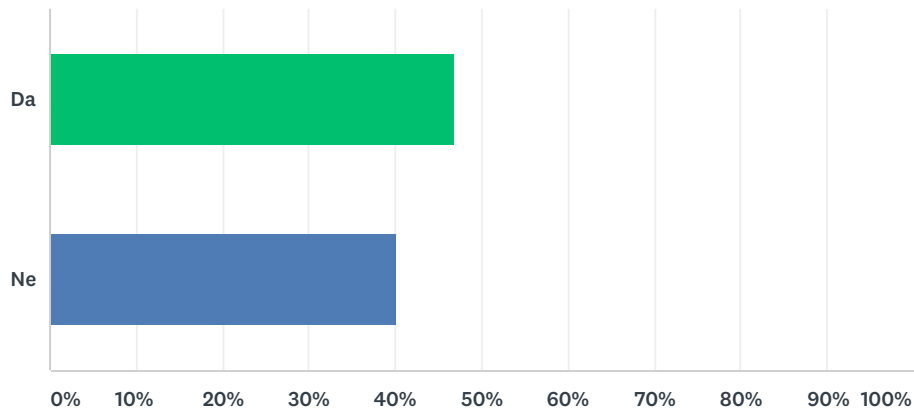

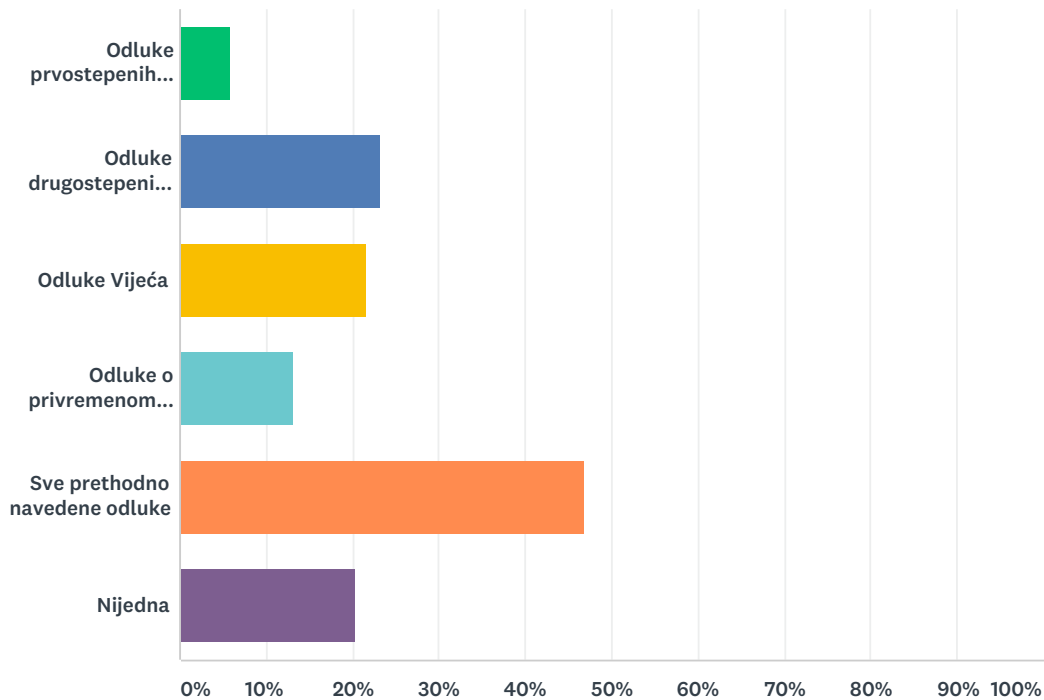

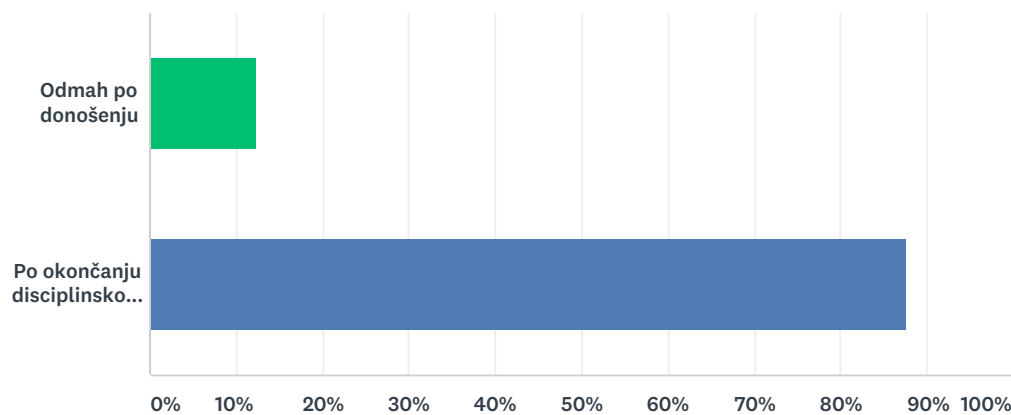

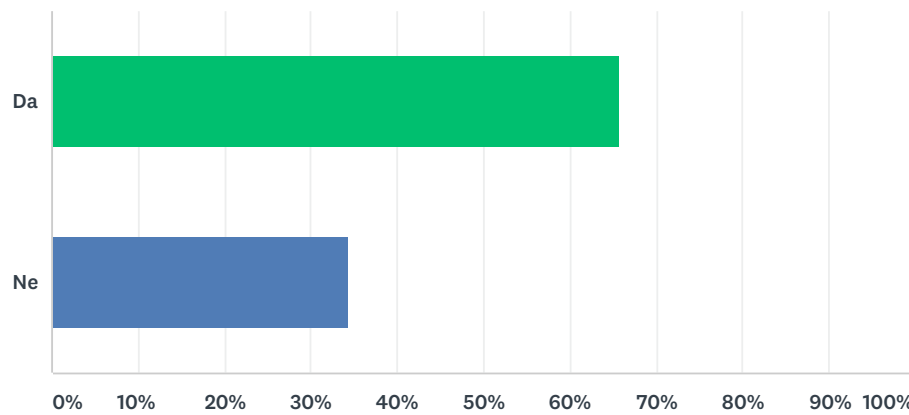

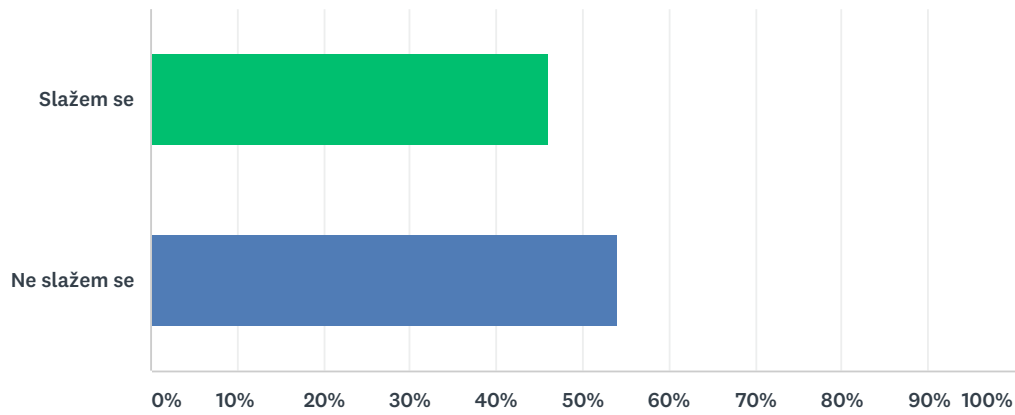

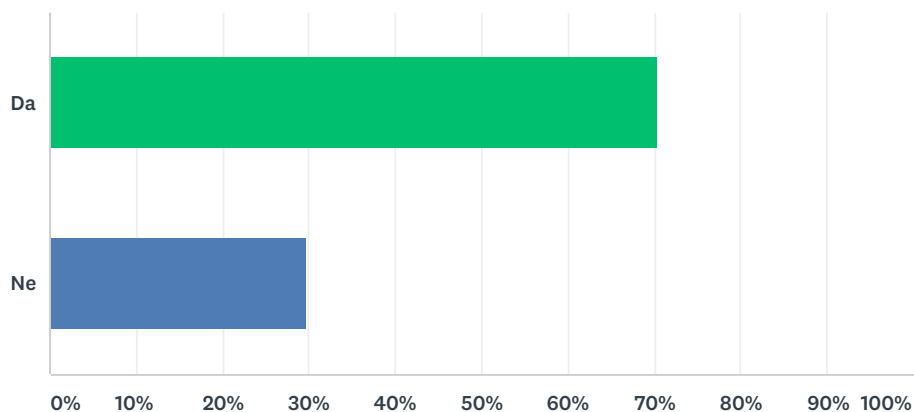

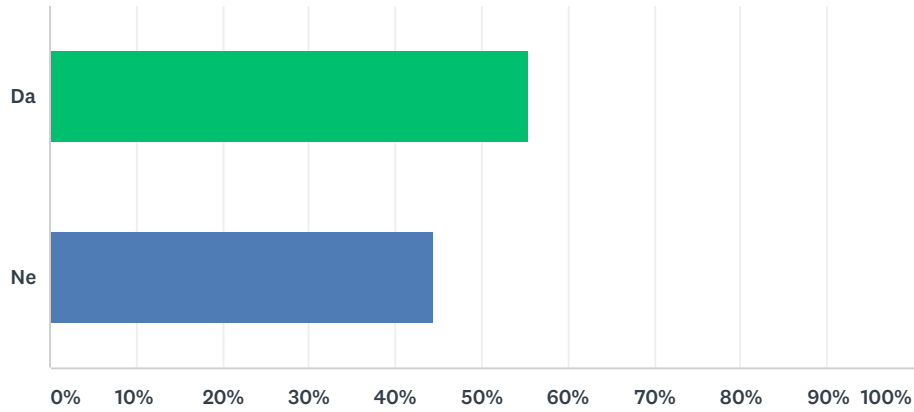
